

# TOWN OF HOLDEN BEACH PARKS AND RECREATION ADVISORY BOARD THURSDAY, APRIL 4, 2019- 2:00 P.M.

The Parks and Recreation Advisory Board of the Town of Holden Beach, North Carolina met at 2:00 p.m. on Thursday, April 4, 2019 in the Town Hall Public Assembly. Present were: Members Dolly Mitchell, Olivia Gomez, John McEntire, Suzannah Tucker and Candace Vick. Assistant Town Manager Ferguson was also in attendance.
